This campaign has a broad range that we are trying to reach; male, female, old and young. BABY YOUR BABY - on going campaign - this campaign focuses on women 18-35, sharing the message of seeing your doctor 13 times during your pregnancy and by the 13th week you are pregnant. We cover stories, have in studio interviews and maintain multiple social media platforms that encourage women to participate in pre-natal and post-delivery care. DAYS OF '47 YOUTH PARADE- In July, we worked with The Days of '47 youth parade. The parade recognizes modern day pioneering and encourages pioneering principles.
