Check Your Health is a campaign that includes media coverage on KUTV & with the Simmons radio group. Commercials and stories are run that encourage viewers to make good choices, be active and eat healthy. This campaign has a broad range that we are trying to reach; male, female, old and young. BABY YOUR BABY - on going campaign - this campaign focuses on women 18-35, sharing the message of seeing your doctor 13 times during your pregnancy and by the 13th week you are pregnant. We cover stories, have in studio interviews and maintain multiple social media platforms that encourage women to participate in pre-natal and post-delivery care. SUPER BOWL OF CARING - KUTV worked with a few corporate sponsors to help fight child hunger in Utah. This is our third year raising funds to help Utah children get solid meals. We held a 17-hour telethon and in conjunction with our corporate sponsors and and local schools, raised hundreds of thousands of dollars as well as food donations. Over the past three years, we have helped raise more than one million dollars. Benefactors include the Utah Food Bank and Catholic Community Services.
