Although not required to do so, the station elected to reschedule the episode of Teen Kids News pre-empted by this breaking news coverage in its second home on 6/18 at 12:30 p.m. The station claims credit in its average weekly core total on the main digital channel for the rescheduled episode (not the episode pre-empted by breaking news). In this one instance, because it was able to accommodate a make-good, the station has elected not to treat the 6/12 pre-emption of Teen Kids News as a breaking news pre-emption. Additionally, Teen Kids News had another pre-empted episode on 6/4 for network sports, but the station did not reschedule this episode. ONE OR MORE EPISODES OF CHILDREN'S PROGRAMMING THAT WAS PREEMPTED DURING THE QUARTER WAS NOT RESCHEDULED. THE DIGITAL CORE PROGRAMMING SUMMARY OF THIS REPORT WOULD NOT PERMIT THE STATION TO INCLUDE PREEMPTION REPORTS FOR SUCH PREEMPTIONS, AND FCC STAFF ADVISED THAT NO PREEMPTION REPORT FOR SUCH UNRESCHEDULED EPISODES WAS NECESSARY.
