Core programming furnished by the NBC Network that contributes to serve the educational and informational needs of children 16 years and under is located in our public file. KNVN also provided educational tours of the station and information to school age children. KNVN weather casters and News Anchors visit area schools to encourage and talk with children. Some of these students have become local "weather-watchers."

While the show will be enjoyed by preschoolers, the projects are also very practical and engaging to implement for children ages 5-8.
