The station has continued to air PSAs for local and national organizations serving the interests of children and families, including those from the Ad Council to increase the number of parents who are actively helping their children with learning and attention issues. Champions Against Bullying Campaign creating an awareness of the effects of bullying. We also have presented stories in our newscasts highlighting children's issues, including how tracking motion helps children learn to walk; steps to prevent pink eye; how children growing up around dogs have an increased chance of asthma; and tips for teens on managing stress. The station continues to provide tours of our facility to local schools to show where and how the news is produced, and to answer questions on what skills are needed to work in the industry, including education.
