News Director, Jon Ellis, explained how the newsroom functions. News Photographer, Paul Walsh, described the photographer's job and how to edit video. Brandon Wagner, Engineer, explained his job as board operator and Dan Romano, Reporter/Meteorologist, described the studio, as well as put them on the green wall (key). On May 18th, WDIO's Anchor, Maarja Anderson & Photographer, Carl Sauer, interviewed a group of elementary students, and learned about what they do to create their weekly radio broadcast of news and events through the area. The students learned about news, what things happen to put on a daily newscast, and what classes to study to get into broadcasting. On November 3rd, Chief Meteorologist Justin Liles talked with 2nd grade elementary students from Cooper Elementary, Superior about the weather for their weather unit. On November 10th, Chief Meteorologist Justin Liles, News Director Steve Goodspeed and Sales Rep Eric Nicholson brought a group of boys from a Boy Scout Troop in to visit/tour the station and to watch our News "Live". The Scouts asked questions about weather and forecasting. On November 29th, WDIO's Anchor/Reporter Maarja Anderson gave a tour of our broadcast facilities to first grade elementary students from Queen of Peace (Cloquet). The students learned about news, what things happen to put on a daily newscast, and what classed to study to get into broadcasting. Due to technical difficulties, Jack Hanna Wild Countdown on 10 /8/2016 as cut short to allow Ocean Treks to start on time at 930AM.
