This is in addition to the 3 hours of core programming as supplied by CBS. Note that WYOU-TV launched the ESCAPE network on its D2 channel and the BOUNCE network on its D3 channel on Friday, 8/26/2016. Due to a technical error, 12.5 hours of BOUNCE network programming that aired between 9/10/16 and 10/15/16 did not contain the E/I symbol. The technical issue has since been resolved, and, with one exception on 11/05/16, all regularly scheduled BOUNCE programming has included the E/I symbol as of 10/22/16. BOUNCE established new processes to ensure that this issue does not recur. To address any possible concerns about compliance with FCC requirements for E/I programming, BOUNCE rebroadcast the 12.5 hours of E/I programming that originally aired without the E/I symbol, for a total of 12.5 hours of E/I programming in addition to BOUNCE's regularly scheduled E/I programming.
