The content of the stories ranged from: Strong bodies and minds... better learners are top priority for the grass roots organization in Montgomery County, MD. They are promoting healthy school food.....Dozens of public and private schools from across the state were represented as their finest swimmers lined up to make some waves and go for the gold.....For 133 students at Back Creek Elementary, they all received a new pair of sneakers. Kids Cast - Every Wednesday during our 5PM newscast weather segment, a third through fifth grade school student gives our weather forecast. Children draw a picture of " weather events" and submits it to our local kids cast sponsors. Each week, a picture is chosen and the child that drew that picture sits on our live news set and delivers the weather for the School Bus forecast. The child arrives early, and in addition to learning about the weather, they get to see how a live newscast works "behind the scenes." During the Month of January there were 61 30-second promos that aired for the Play of the Week. Each week, a different male or female athlete is chosen as our Play of the Week. During the month of February 61 30-second promos were aired. And during the month of March 61 30-second promos aired promoting Play of the Week. On January 27 a tour from Daily Companions Inc. from Martinsburg, WV toured the station. They toured the news room, studio and control room and weather center. On March 29 a group from the Franklin County Learning and Activity Group toured the station. They toured the news room, studio, control room and weather center. .
