The programs whose episodes were preempted that day are Heart of a Champion with Lauren Thompson (9:30 AM), Voyager with Josh Garcia (10 AM), Wilderness Vet (10:30 AM), Journey with Dylan Dryer (11 AM), Naturally, Danny Seo (11:30 AM), and Give (12 PM). In addition, several episodes of children's programming on the Station's main digital channel were preempted on Sunday, September 10th, due to national breaking news coverage of Hurricane Irma. The programs whose episodes were preempted that day are Teen Kids News (12 PM and 12:30 PM). One or more episodes of children's programming that was preempted during the quarter was not rescheduled. The Digital Core Programming Summary section of this report would not permit the station to include preemption reports for such unrescheduled preemptions, and FCC Staff has advised that no preemption report for such unrescheduled episodes is necessary. During this quarter, WBAL-TV scheduled three additional episodes of the regularly scheduled core children's program, "Teen Kids News." These additional episodes of the regularly scheduled core children's program, "Teen Kids News." These additional airings were intended to help increase audience awareness of the program and to further educate and inform teen viewers about topical, current news events. The importance of engaging teen viewers in news-of-the-day which is a principal goal of the station's airing of these additional episodes cannot be overstated, as big news stories occurred during the Third Quarter, and the episodes also examined significant social and cultural developments and "feel good" stories to expand the worldview and socio-cultural literacy of teen viewers.
