In the Third Quarter 2017, WNJX-TV broadcasted a significant amount of public service announcements for an antidrug campaign, alcoholism disease, homeless, cyber bulling, domestic violence, child abuse, children with special needs, environmental, emergency plan, sports and health related issues such as, prevention H1N1, ZIKA and cancer and renal disease. On September 29, 2017, the FCC extended the deadline to November 13, 2017 for stations in Puerto Rico to file their Children's Television Programming Reports (DA-17-870). Additionally, on September 20, 2017, WTIN-TV went silent as a result of damage caused by Hurricane Maria. The station resumed operations on October 3, 2017.
