WYFF 4 supports our children's programming efforts through community service outreach and non-broadcast efforts that serve the educational and informational needs of children. Information supporting our community outreach/non-broadcast efforts is maintained with this report in our Children's Public File. Efforts for 4th quarter included our Holiday Sunshine Fund in conjunction with the Greenville News. That effort raised over \$10,000 to help with food, heating, and clothing for children in need. We also teamed with the Greenville Hospital System for the Virtual Toy Drive. In eleven years WYFF 4 has helped raise over \$680,000 for the Children's Hospital.
