Teen Kids News aired as scheduled on December 16th, but was joined in progress eight minutes late on December 23rd due to a network sports overrun. On December 30th, Teen Kids News was also joined in progress due to a network sports overrun, but the first 17 minutes of the program did not air as a result of the overrun. For that reason, we did not include the December 30th episode of Teen Kids News in our program average for the quarter. In addition, KCCI aired five special edition episodes of the core, E/I children's program -- Jack Hanna's Into the Wild -- in an effort to increase audience awareness of this series which premiered this quarter on KCCI. Jack Hanna's Into the Wild was designed to educate and inform viewers about amazing creatures and cultures, world geography and natural history, and the importance of environmental stewardship.
