Pursuant to the FCC Spectrum Auction, WDLI-TV completed the implementation of channel sharing operations on March 30, 2018. WDLI-TV moved to Canton, Ohio Channel 23 and Virtual Channel 17, licensed to Trinity Broadcasting Network. This change eliminated the multicast channels, which modified the overall average number of hours per week of Children's programming on those channels, but did not impact the primary channel.
