The late-breaking nature of her passing and scheduling of her funeral service were beyond the control of the station and made it impracticable for the station to reschedule HEALTH & HAPPINESS WITH MAYO CLINIC and THE CHAMPION WITHIN. In addition, the breaking news coverage caused core program NATURALLY, DANNY SEO to be interrupted approximately 10 minutes prior to the end of the show; because the show aired substantially in its entirety, a preemption report for that episode is not included in the Digital Core Programming Summary section of this report.
