In addition, on September 1, 2018, core programs "The Champion Within," "Voyager With Josh Garcia," "Wilderness Vet," "Journey with Dylan Dreyer," "Naturally, Danny Seo," and "Health & Happiness with the Mayo Clinic" were preempted from their regularly scheduled times from 9:30am-1pm to air breaking news coverage of the funeral proceedings of American hero and Senator John McCain. The late-breaking nature of his passing and scheduling of his funeral service were beyond the control of the station and made it impractical for the station to reschedule "The Champion Within," "Voyager With Josh Garcia," "Wilderness Vet," "Journey with Dylan Dreyer," "Naturally, Danny Seo," and "Health & Happiness with the Mayo Clinic." Finally, the station added two, special editions of Core Program Teen Kids News at 2pm and 2:30pm on August 19, 2018, in order to, among other things, gauge viewer interest in the program at these times in order to help analyze whether the station might utilize those time slots as potential "second homes" for Teen Kids News when the show is preempted and rescheduled in the future.
