The late-breaking nature of his passing and scheduling of his funeral service were beyond the control of the station and made it impracticable for the station to reschedule Jack Hanna's Wild Countdown, Ocean Treks and Vacation Creation. WPBF was able to reschedule Sea Rescue, The Wildlife Docs and Rock the Park on Sunday September 2, 2018 at 2:30p, 3:00p and 3:30p.
