On October 27, 2018, core programs CONSUMER 101, NATURALLY, DANNY SEO and VETS SAVING PETS were preempted from their regularly scheduled times at 11:00 AM, 11:30 AM and 12:00 PM to air breaking news coverage of the tragic shootings in Pittsburgh, PA. The late-breaking nature of this event was beyond the control of the station and made it impracticable for the station to reschedule CONSUMER 101, NATURALLY DANNY SEO and VETS SAVING PETS. On December 1, 2018, NATURALLY DANNY SEO was partially preempted for approximately 9 minutes to air breaking news coverage about the death of former president George H. Bush. One or more episodes of children's programming that was preempted during the quarter was not rescheduled.
