On Saturday, October 27, 2018, core program Vacation Creation with Tommy Davidson and Andrea Feczko was preempted from its regularly scheduled time at 10:32 AM thru 10:45 AM to air breaking news coverage of the shooter in custody at the tree of life synagogue. On Sunday, December 2, 2018 core program Into the Outdoors ran in its entirety at 11:30 AM but did not have the E/I symbol. The syndicator did not offer a make-good version with the E/I logo. One or more episodes of childrens programming that was preempted during the quarter was not rescheduled. The Digital Core Programming Summary section of this report would not permit the station to include preemption reports for such unrescheduled preemptions, and FCC Staff has advised that no preemption report for such unrescheduled episodes is necessary.
