Our meteorologist explains weather and station components, including weather computers and how they track the weather systems. On Saturday, October 27, 2018, core program Vacation Creation with Tommy Davidson and Andrea Feczko was preempted from its regularly scheduled time at 10:32 AM thru 10:45 AM to air breaking news coverage of the shooter in custody at the tree of life synagogue. On Sunday, December 2, 2018 core program Into the Outdoors ran in its entirety at 11:30 AM but did not have the E/I symbol. The syndicator did not offer a make-good version with the E/I logo. One or more episodes of childrens programming that was preempted during the quarter was not rescheduled.
