On Saturday, January 12, 2019, core programs Naturally, Danny (9:30am), The Voyager (11:00am) and Earth Odyssey (11:30am) were pre-empted to air breaking news coverage regarding the funeral procession for a local fallen Colerain Police Officer who was killed in the line of duty. The late breaking nature and scheduling of this event along with the fluidity of the situation were beyond the control of the station and made it impracticable for the station to reschedule these three programs. On Sunday, January 13, 2019, WLWT aired 4 additional, back-to-back episodes of regularly scheduled core children's program "Teen Kids News, " which created a marathon of 5 episodes from 12:30pm-3:00pm. The marathon was intended to increase audience awareness of the program and to further educate and inform the teen audience about significant news events during a period of political transition and turmoil, including the partial government shutdown. Engaging teen viewers in "news of the day," which is a principal goal of these additional episodes, cannot be overstated. Program content also included social and cultural developments and "feel good" stories designed to expand the literacy and world view of the teen audience. In short, these episodes were scheduled to update teens about recent events and reports. These additional core episodes were promoted via anchor announcements during newscasts and via multiple on-air crawls. One or more episodes of children's programming that were preempted during the quarter were not rescheduled. The Digital Core Programming Summary section of this report would not permit the station to include preemption reports for such un-rescheduled preemptions, and FCC Staff has advised that no preemption report for such unrescheduled episodes is necessary.</p>
