WLWT also has a dedicated link on the WLWT.com homepage, State of Addiction, with local and national content providing updates and information for viewers. In 2019, WLWT has also added another initiative called Project Community. These stories will focus on several issues, many affecting children such as school violence, bullying and the impacts of social media. On Saturday, January 12, 2019, core programs Naturally, Danny (9: 30am). The Voyager (11:00am) and Earth Odyssey (11:30am) were pre-empted to air breaking news coverage regarding the funeral procession for a local fallen Colerain Police Officer who was killed in the line of duty. The late breaking nature and scheduling of this event along with the fluidity of the situation were beyond the control of the station and made it impracticable for the station to reschedule these three programs.
