On Monday, September 3, 2018 at 5am local time, the Licensee commenced the airing of the Start TV digital network on its digital subchannel 11.2 which airs three hours per week of educational and informative programming for children 16, commencing Sunday, September 9, 2018 TFN and in accordance with FCC rules and regulations.
