On May 1, Gray Television took ownership of the station and the programming aired from that date on was under Gray Television's ownership and control. As noted on in the Digital Core Summary, on May 11 and on May 18th, CLICK CULTURE and AMERICA's HEARTLAND were preempted from their regularly scheduled time period on WWNY's secondary program channel due to FIFA Soccer (sports). Both shows were rescheduled for the following day in a secondary home. Also noted on in the Digital Core Summary, on June 8, the secondary DTV program channel of program ROCK THE PARK was preempted at 8:00AM due to technical difficulties with the show. It was made-good at 10:00AM the same day. A crawl alerting the public of the change was broadcast. This station conducts tours and participates in career days for school-aged children, exposing them to the technology and career opportunities in broadcasting.
