On May 1, Gray Television took ownership of the station and the programming aired from that date on was under Gray Television's ownership and control. As noted on in the Digital Core Summary, on May 11 and on May 18th, CLICK CULTURE and AMERICA's HEARTLAND were preempted from their regularly scheduled time period on the primary channel due to FIFA Soccer (sports).
