On May 1, Gray Television took ownership of the station and the programming aired from that date on was under Gray Television's ownership and control. As noted on in the Digital Core Summary, on May 11 and on May 18th, CLICK CULTURE and AMERICA's HEARTLAND were preempted from their regularly scheduled time period on the primary channel due to FIFA Soccer (sports). Both shows were rescheduled for the following day in a secondary home. Also noted on in the Digital Core Summary, on June 8, the program ROCK THE PARK was preempted at 8:00AM on the primary channel due to technical difficulties with the show. It was made-good at 10:00AM the same day. A crawl alerting the public of the change was broadcast. WNYF-CD's secondary program stream is affiliated with MeTV. It should also be noted that the source of the programming is listed as network, as it is provided by the sub-net MeTV. This station conducts tours and participates in career days for school aged children, exposing them to the technology and career opportunities in broadcasting. WNYF broadcasts news M-F 6-8AM and 10PM. While not specifically targeting children, these broadcasts include news and information of interest to children 16yrs of age and under. This news and information includes, but is not limited to, local &amp; world news, sports and weather.</p>
