In order to average at least 12.0 hours per week of core programming over the station's four digital program streams (averaged over a six-month period), the station originally intended to air an additional 1.0 hour per week of core programming on its digital program streams throughout the third quarter. However, due to scheduling and other logistics, the station aired an additional 2.0 hours per week of core programming on each of its D4 and D5 digital program streams from August 18-September 29, 2019 in order to average at least 12.0 hours per week of core programming over the station's four digital program streams (as averaged over a six-month period, i.e., the second and third quarter of 2019).
