Due to an inadvertent scheduling error, certain of the station's core programs on the station's D4 and D5 digital program streams aired from 6-7am, local Hawaii time, and therefore were not included in the calculation of the average number of hours per week of core programming broadcast by the station on its digital program streams in the second quarter. In order to average at least 12.0 hours per week of core programming over the station's four digital program streams (averaged over a sixmonth period), the station originally intended to air an additional 1.0 hour per week of core programming on its digital program streams throughout the third quarter.
