On August 31, Children's programming was interrupted multiple times for breaking news reports on hurricane Dorian, none of the programs were interrupted in their entirety. On September 2 and 3, Renio Animal was pre-empted due to breaking news coverage of hurricane Dorian. One or more episodes of children's programming that was preempted during the quarter was not rescheduled. The Digital Core Programming Summary section of this report would not permit the station to include preemption reports for such unrescheduled preemptions, and FCC Staff has advised that no preemption report for such unrescheduled episode is necessary.
