For clarification, within Digital Core programming it was noted that Click Culture aired 10 times on Saturday as did Outback Adventures with Tim Faulkner on Sunday. In both cases they were replaced by The Great Dr Scott, which aired once each day within this reporting period and will air in those time periods UFN. Under the advice of counsel, identifying future broadcasts is not required but was advised that in order to complete and file this report one program may/would need to be identified. This station conducts tours and participates in career days for school-aged children, exposing them to the technology and career opportunities in broadcasting. WWNY-TV broadcasts local news at 6AM, Noon, 6PM and 11PM M thru F, and 6PM and 11PM Saturday's and Sunday's. The secondary DTV channel also airs news M thru F 6 8AM and 10PM. While not specifically targeting children, these broadcasts include news and information of interest to children 16yrs of age and under. This news and information includes, but is not limited to, local and world news, sports and weather.
