For clarification, within Digital Core programming it was noted that Click Culture aired 10 times on Saturday as did Outback Adventures with Tim Faulkner on Sunday. In both cases they were replaced by The Great Dr Scott, which aired once each day within this reporting period and will air in those time periods UFN. Under the advice of counsel, identifying future broadcasts is not required but was advised that in order to complete and file this report one program may/would need to be identified. WNYF CD's secondary program stream is affiliated with MeTV. It should also be noted that the source of the programming is listed as network, as it is provided by the subnet MeTV. This station conducts tours and participates in career days for school aged children, exposing them to the technology and career opportunities in broadcasting. WNYF broadcasts news MF 6 thru 8AM and 10PM. While not specifically targeting children, these
