For the target audience, it is essential that the information is not dumbed down, which it is not in ON THE SPOT. The program is peppered with breakout segments designed to be interactive, calling for the viewer to respond. These include the "Speed Round" (with ticking clock graphic), "Clinical or Cynical", and Solved or Unsolved". The segments keep this from being a passive viewing experience, another nice point when targeting viewers with information and education.</p>
