While that may not match what was actually aired, it is nevertheless being provided in good faith. In addition, both SOAC and JUCE provide 40 hours of routine children's programming over their daily schedules, and based on those routine schedules KAAH believes it provided the required children's programming on the single multicast channel SOAC and JUCE share at KAAH.
