On Saturday, July 16, a portion of Innovation Nation and all of The Inspectors was pre-empted due to breaking national news coverage of Donald Trump announcing his VP running mate. WLKY sponsors a weekly segment of "Wednesday's Child," which highlights special needs children awaiting adoption in Kentucky. To date, more than 4,000 children have been placed in permanent adoptive homes through the Wednesday's Child Program. WLKY routinely provides tours for local students and student shadow sessions to point out broadcast opportunities.
