On 7/16, Born to Explore (Saturdays 11:30am-12pm) was preempted in its entirety on the main channel due to the same breaking news event mentioned above. 3. On Saturday, 9/3 /16, the program Whaddaydo (Saturdays 7-7:30 am) on the main program stream was interrupted at approximately 7:24 AM due to technical difficulties. Although the interruption was brief in nature, the station elected to reschedule the episode to its second home. The station has counted this episode only once.
