The goal of this annual effort is to raise funds to help improve the quality of life for children with disabilities. All programs were made-good on December 11 and 25, promotional efforts with the rescheduled times and date were aired. On the station's fourth digital stream: On or about October 25, 2016 LAFF TV notified this station that due to a technical error, all programs aired on LAFF TV from October 1, 2016 to October 15, 2016 aired without the requisite E/I symbol: The FCC was informed at that time. In total, 10.5 hours of E/I programming did not include an E/I symbol. LAFF TV has informed this station that it has established new processes to ensure the technical issue does not recur. Additionally, the affected programs were re-broadcasted with the E/I symbol during this quarter.
