Due to the fact that we missed E/I programming because of breaking news coverage of severe weather, we did not reschedule the missed programming in its second home. 2) The station's children's core programming average reported in the Digital Core Programming section of this report takes into account the fact that the First Quarter 2017 only had 12 Saturdays. Because all of the station's core programs on the 22.1 channel aired on Saturdays, the calculation for the main 22.1 channel in the Digital Core Programming section is "artificially" low as a result of this quirk of the calendar.
