In each episode Chica developes or encounters a problem that she cannot immediately resolve, Usually her issues involved impulse control, distractibility, judgment and inter-personal behaviors. She and Kelly usually work on the problem through an adventure-a fantasy transformation to animation -- where Bunji and Stitches come alive and join Chica and Kelly for the problem solving process. The core educational content is primarily socio-emotional development, and Chica learns how to express herserlf properly, think before she acts, and interact with other effectively. She often learns that it takes hard work and practice to become proficient at different skills
