Lucky Dog aired as scheduled on February 24th and March 24th, but was joined in progress 20 minutes late on January 20th due to a network sports overrun. Since the first 20 minutes of Lucky Dog did not air, we did not include the January 20th episode of Lucky Dog in our program average for the quarter. In addition, two of our core children's programs Lucky Dog and Teen Kids News were briefly interrupted on March 24th by CBS News Special Reports on the March for Our Lives rally in Washington, DC; Lucky Dog was interrupted from 11:00:04-11:01:46am and Teen Kids News was interrupted from 12:00:04-12:05:15pm on March 24th. RE: Jack Hanna's Into the Wild: Special Edition. Originally introduced to our teen audience in fourth quarter of 2017, KCCI scheduled two special edition, mini-marathons of Jack Hanna's into the Wild in first quarter to further increase audience awareness of this educational series for teens. As a limited number of episodes aired last quarter, these mini-marathons served to supplement the educational experience by informing teens about different creatures and cultures around the world and by focusing on the importance of natural history and environmental stewardship. KCCI notified the television listing services in advance about the broadcast dates and times of Jack Hanna's Into the Wild and also aired crawls promoting these special edition episodes.
