After due review of internal station records and documentation provided to us by program suppliers, the licensee hereby certifies that the station fully complied with the FCC's commercial limits in children's programs, as specified at 47 C.F. R. Section 73.670, with respect to all programs specifically designed for children ages twelve and under. In addition to the educational or informational programs listed in the report, the station broadcast the following programs specifically designed for children ages twelve and under that were not "educational or informational" programming: None. The time period changes for the Cozi TV programs were caused by the start of Daylight Saving Time. Arizona does not use DST and KPHO passes through the live Cozi TV network feed, so all Cozi programming on KPHO shifted one hour at the start of DST. The preemptions on KPHO 5.1 on Saturday January 6th were caused by technical issues which slightly shortened Henry Fords Innovation Nation and caused Lucky Dog 2 and The Inspectors to air out of pattern.
