WLWT also has a dedicated link on the WLWT.com homepage, State of Addiction, with local and national content providing updates and information for viewers. On January 31st, 2018 WLWT hosted a group of 16 female 5th and 6th grade students from the Cincinnati Preparatory Academy. The students toured the television station and met with several employees who provided 15 to 20 minute sessions explaining their job description/duties along with explaining their own personal journeys through middle school, high school, college and their eventual career paths. These students are part of an organization, GIRLS with PEARLS. This organization serves female students during their transition years. Program participants include students who are considered at risk to students who are considered school exemplars. Students typically participate in GIRLS with PEARLS, for three reasons: to make differences in peers lives, for sisterhood, and for change. Active engagement in the program strengthens skills while girls lead by example. Participants make and share friendships while creating a sisterly environment moreover, find commonalities. Having a comfortable environment encourages students to interact and express one to another, resulting in an openness to change. On March 14, 2018, as part of our State of Addiction commitment, WLWT hosted a phone bank and Facebook Live event during our 5pm to 630pm newscast. Experts from local treatment facilities provided information and resource options to those viewers, including teenagers , calling in seeking services and options for working towards a recovery plan for various abuse issues.
