On April 21, 2018, core program Health plus Happiness with Mayo Clinic was preempted from its regularly scheduled time at 12 pm to air breaking news coverage of the funeral proceedings of former First Lady and American icon Barbara Bush. The late-breaking nature of her passing and scheduling of her funeral service were beyond the control of the station and made it impracticable for the station to reschedule this episode in its second home. However, the station was able to reschedule this episode later that same day, April 21, at 2 pm. Similarly, also on April 21, 2018, the station had planned to preempt the regularly scheduled episode of The Champion Within at 930 am and air it in its second home at 1230 pm. However, due to the breaking news coverage for the Bush funeral service referenced above, the episode was further preempted, but the station was able to reschedule this episode later that same day, at 230 pm.</p>
