Due to a technical error which has since been corrected, on Sunday, May 6 the E/I bug did not appear on screen during the regularly scheduled 6:00 PM episode of Crossfire Service. A make-good episode was scheduled and aired on May 27, 1:00 PM. 3.) On Saturday, March 31, E/I program Generation of the Cross was pre-empted from its regularly scheduled 12:00 PM time slot and rescheduled to air the same day, March 31 at 10:00 AM to accommodate a one time special live program, "Resurrection Campmeeting".
