On September 1, 2018, core programs- Jack Hanna Sat. 10am, Ocean Treks Sat. 1030am, Sea Rescue Sat. 11am, The Wildlife Docs Sat. 1130am, and Teen Kids News Sat. 12n were preempted from their regularly scheduled times due to breaking news coverage of the funeral proceedings of American hero and Senator John McCain.
