On October 27, 2018, on the station's main digital channel, core programs Consumer 101, Naturally, Danny Seo, and Vets Saving Pets were preempted from their regularly scheduled times at 11:00 am, 11:30 am, and 12:00 pm, respectively, in order to air breaking news coverage of an active shooter in Pittsburgh where multiple police officers had been shot. The station was unable to reschedule the episodes due to the late breaking nature of the news. On December 1, 2018, on the station's main digital channel, core program Naturally, Danny Seo was partially preempted from 11:41 am to 11:51 am from the regularly scheduled time of 11:30 am, to provide breaking news that President George H.W. Bush had passed away. The station was unable to reschedule the episode due to the late breaking nature of the news. On December 9, 2018, on the station's main digital channel, core program Teen Kids News was preempted from the regularly scheduled time at 11:00 am due to breaking news and weather coverage of a major snowstorm which hit the Piedmont Triad area of North Carolina. In addition, core programs on our Multicast channel Beakman's World and Bill Nye, The Science Guy were preempted from their regularly scheduled times at 8:00 am, 8:30 am, 9:00 am, and 9:30 am, respectively, to air the NBC News Programs preempted due to the breaking news and weather coverage of the snowstorm. Note: One or more episodes of children's programming that were preempted during this guarter were not rescheduled. The Digital Core Programming Summary section of this report would not permit the station to include preemption reports for such non-rescheduled preemptions, and FCC staff has advised that no preemption report for such non-rescheduled episodes is necessary.
