The viewers of WHEC TV often face severe weather conditions and the local weather updates, forecasts and live radar provided a public service and enhanced public safety by offering continuous information about local weather, including dangerous or imminent weather events. The Stations records indicate that this stream did not receive any cable or DBS carriage. At the time of the initial submission of this FCC Form 398 on October 10, 2017, WHEC TV appears not to have included this multicast stream.
