WMTJ-TV airs PBS Network which has an abundance of E/I Children's Programs. Monday through Friday there are over 20 hours of children's programs between 7am and 6pm. Additionally on Saturdays and Sundays there are 9 hours. During this quarter there were preemptions on 6/17, 6/19, 6/20 and 6/21 these were not made good, however generally they are preempted by another E/I Children's program. On the main digital stream Atencion Atencion was suspended during the quarter from May 13 to May 17, 2019. Around May 8, 2019 the station was made aware of public accusations and an ongoing investigation against one of the former bandmembers of Atencion Atencion. Pending further developments in the investigation, the station pulled the show off the air immediately. After discussions with the production company, the band member was removed from all episodes of this program. The program was subsequently placed back into the E/I rotation on May 20, 2019 in its regularly-scheduled timeslot. Due to the extraordinary circumstances of this matter, the station aired an extended hour of Planeta de Ninos (Kid's Planet).</p>
