Born to Explore was interrupted and Sea Rescue was joined in progress. Because of the timing of the report, the majority of Born to Explore aired, while the majority of Sea Rescue was missed. The Children's Television Act and the FCC's rules require that programming targeting children ages twelve and under may not contain more than 10.5 minutes of total commercial matter per clock hour on weekends and no more than 12.0 minutes of total commercial matter per clock hour on weekdays.
