Kids get an extensive tour of the station, have an opportunity to get in front of the camera and even watch a live newscast. 10LEADERSHIP AWARDS are presented to community leaders who have founded non-profit organizations or have been instrumental in organizing projects and fundraisers in San Diego. During the Fourth Quarter of 2014, one of our recipients was a 14-year-old ninth-grade student who has raised more than \$30,000 for leukemia and lymphoma support and research. After her aunt passed away from leukemia seven years ago, Sophia set up a stand offering lemonade and cookies in her driveway on her late aunt's birthday. Over the years, neighbors and local businesses joined in. Now her neighborhood has an annual block party catered by community businesses, a silent auction of goods and services donated by the community, a bounce house, face-painting, live music and more. This year alone, Sophia's Cookies for a Cure and Lemonade Stand collected more than \$12,000 for support and research.
