WDEF aired PSAs which were of benefit to the youth and adults alike during the 3rd quarter of 2015. A complete listing of the PSAs which aired on 12.1 and 12.2 during this guarter can be found in our public file. An initiative sponsored by the station was a news segment called Whats Right with Our Schools. WDEF News Anchor John Mercer featured a segment each Monday during the 6pm newscast highlighting educators, students, individuals or community groups which worked with the students and schools in an extraordinary manner and who went above and beyond the norm in helping to educate children through life lessons. Some examples of What's Right with our Schools include Camp Invention A summer camp for kids is helping them set goals, build their self esteem and learn about teamwork. Camp invention teaches students about science, technology, engineering and math in a fun and creative way. Another segment featured Robotics School where some students got an early jump on high tech subjects. They spent part of their summer learning about robots and the coding that comes with them. The lessons took place at the Chattanooga School for Liberal Arts. Another segment featured Math and Movement where some students and teachers are ready for the new school year, after spending part of their summer vacation studying math. The National Math Foundation Summer Institute took place at Orchard Knob Elementary. WDEF and Chief Meteorologist, Patrick Core sponsor a program called Kidcaster where local kids and parents can go to our website and tell why their child would like to be a Kidcaster. After a child is selected, they, along with their family members come to the TV station for a tour then go behind the scenes to observe a newscast as it's televised live. Near the end of the 7pm newscast they are introduced on the air as our kidcaster for the day. Afterwards, the student along with the meteorologist assistance prepare and tape a forecast for the next day. The segment airs during our 11pm news that evening and again the next morning during our morning news. Each child receives a personalized Kidcaster certificate and a DVD of their on air kidcaster weather report. This quarter we had children from Harmany Elementary School in Chatsworth, GA, Pleasant Grove Elementary, Dalton, GA, Hardy Elementary, Hunter Middle and Westside Middle here in Chattanooga among others. We also feature a High School Band Spotlight weekly during our Thursday night 11pm newscast which highlights a high school band in our viewing area and includes a performance by the band. Our Touch Down Friday Night segment included interviews and performances by cheerleaders as part of our game of the week during our 6 and 7pm newscasts during the high school football season. Meterologist, Megan Wise also gave a weather presentation for the 3rd grade at the Chattanooga School for Liberal Arts. The video presentation included how weather forecasts are determined, various cloud formation followed by a question and answer session with the 3rd graders. WDEF also provided ID wristbands at the Hamilton County Fair, which listed the childs parents cell phone number on them should they become separated from their parents while attending the fair..

This program offers teens an opportunity to view everyday people - regardless of age, sex, occupation or education - stepping forward and acting in a socially responsible and moral fashion when faced with crises and moral dilemmas. In a candid camera-type format, individuals are placed in situations that cause them to demonstrate acts of kindness and generosity, stand up for diversity, shield others from bullies, and embrace friendships.
