Thirteen-year-old Miley Stewart, recently moved from Tennessee to Malibu, CA, leads a double life. Miley wears blonde wigs while performing, and manages to escape being recognized. Miley's mother died three years before the story begins, so her dad is now a single parent. The boys attend a local public middle school.
